I understand that I must provide documentation to the City in which I have registered with the State Commissioner of Revenue for sales tax purposes within ten (10) days following the issuance of a beer permit. I also understand that failure to provide this information will result in revocation of the permit.

I certify this application contains true information to the best of my knowledge and belief. I am aware of my continuing obligation to amend or supplement this application promptly if a change in circumstances affects the responses provided in this application, either before or after a permit has been issued, including, but not limited to, information regarding myself, other owner, employees, or the addition of new employees. I certify that I am knowledgeable of the laws prohibiting the sale of beer to minors. I will surrender to the Beer Board any permit issued under this application within fifteen (15) days of termination of the business, change in ownership, relocation of the business, or change of the business's name.

**NOTICE:** A non-refundable \$250.00 fee must accompany this application. If the application is approved, you are required to provide documentation of sales tax registration to the City within ten (10) days of approval.

An annual privilege tax of \$100.00 is imposed on the business of selling, distributing, storing, or manufacturing beer in this state. The tax is due each January 1 and is payable to the City of Rocky Top. This tax is prorated for new permits issued after January 1 and must be paid when the permit is issued.

**ANY APPLICANT MAKING A FALSE STATEMENT IN THIS APPLICATION SHALL FORFEIT HIS OR HER PERMIT AND SHALL NOT BE ELIGIBLE TO RECEIVE A PERMIT FOR TEN (10) YEARS.**

**I have read and fully understand the terms and conditions set forth in the application. I understand this application is part of the Beer Permit and further understand that part of the normal procedure for processing this application is a background check. I certify that all information is true and authorize a Tennessee Bureau of Investigation to make the necessary investigation and to release all information to the City of Rocky Top Beer Board.**
